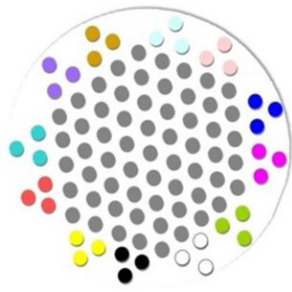
- Established a network of CCS Expertise with members from all BASREC countries but Iceland

A tangible outcome of the Warsaw conference is the creation of a new and combined initiative, under the preliminarily heading of "Knowledge Sharing Program". The working group chaired by Kirsty Anderson will use time in the short perspective to work out a clear project description. This together with a proposition for continued central network activities will be basis for funding applications going into 2016.

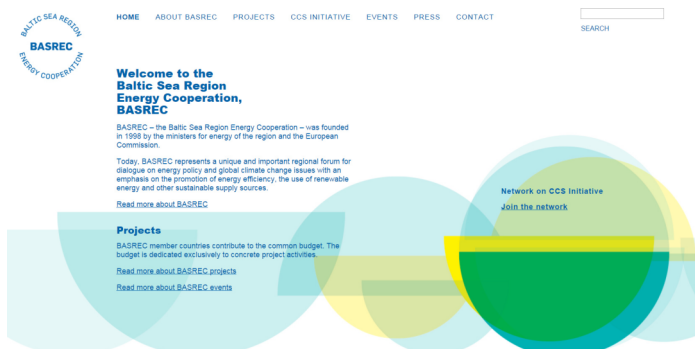
